Understanding the UK Spouse Visa

A UK Spouse Visa allows the partner of a British citizen or a person with settled status in the UK to join them and live together. The spouse visa falls under the family visa category and is granted for an initial period of **30 months**. After the initial period, the applicant can apply for an extension, and eventually for [Indefinite Leave to Remain \(ILR\)](#).

To qualify for a spouse visa, applicants must meet specific criteria, including proof of a genuine relationship, meeting the financial requirement, passing an English language test, and showing suitable accommodation arrangements.



Eligibility Criteria for a UK Spouse Visa

To be eligible for a UK Spouse Visa in 2025, you must meet the following conditions:

1. Relationship Requirement

- You and your partner must be legally married or in a civil partnership recognised under UK law.
- If unmarried, you must have been living together in a relationship akin to marriage for at least **two years**.
- You must have a genuine and subsisting relationship.
- You must intend to live together permanently in the UK.

2. Financial Requirement

- The sponsor (the UK-based partner) must have an income of at least **£29,000 per year** from **11 April 2024**.
- Savings above **£16,000** can be used to supplement income if the earnings fall below the threshold.
- If the sponsor receives certain benefits, such as Disability Living Allowance, the financial requirement may be waived.

3. English Language Requirement

- The applicant must prove knowledge of the English language by passing an approved test at the required CEFR level.
- Holding a degree taught in English or being from a majority English-speaking country may exempt you from this requirement.

4. Accommodation Requirement

- You must have suitable accommodation for yourself, your partner, and any dependants without relying on public funds.

5. Health and Suitability Requirement

- The applicant must pass a Tuberculosis (TB) test (if applicable).

- The applicant must not have any serious criminal convictions or pose a threat to UK security.

UK Spouse Visa Document Checklist

Below is a detailed checklist of the documents required for a UK Spouse Visa application in 2025:

1. Proof of Relationship

To demonstrate a genuine and subsisting relationship, you must provide the following:

- **Marriage or Civil Partnership Certificate** – A legally recognised document confirming your marriage or civil partnership.
- **Evidence of Communication** – Copies of emails, chat logs, call history, and letters exchanged between you and your partner.
- **Photographs** – Pictures of you and your partner together at various events, with family and friends.
- **Travel History** – Flight tickets, boarding passes, and hotel bookings showing that you have travelled together.
- **Relationship Statement** – A written statement detailing:
 - How you met.
 - How the relationship developed over time.
 - Your plans for living together permanently.
- **Divorce Certificate** – If either partner was previously married, provide the divorce certificate.



2. Financial Requirement Documents

To meet the financial threshold, you need to provide clear evidence of income and savings:

- **Payslips** – Last six months of payslips from the sponsor.
- **Employment Contract** – Including job title, job description, salary details, and duration of employment.
- **Bank Statements** – Last six months of statements showing income deposits.
- **Savings Evidence** – Bank statements confirming savings above £16,000 (if applicable).
- **Tax Returns (P60)** – To confirm annual income.
- **Self-Employment Documents** (if applicable):
 - Tax returns.
 - Business accounts.
 - Accountant's letter confirming income.
 - HMRC registration details.

Exemptions from Financial Requirement

You may be exempt from the financial requirement if:

- The sponsor is receiving benefits such as:
 - Disability Living Allowance.
 - Personal Independence Payment (PIP).
 - Carer's Allowance.
 - Attendance Allowance.
- The sponsor has sufficient personal funds to support the applicant without public funds.

3. English Language Requirement Documents

To meet the English language requirement, you must provide:

- **IELTS Life Skills Certificate** – A valid certificate with a SELT reference number from a Home Office-approved centre.
- **Degree Certificate** – If your degree was taught in English, provide an ECTIS (formerly UK NARIC) statement of compatibility.
- **Nationality Exemption** – If you are from a majority English-speaking country (e.g., the USA, Canada, Australia), provide proof of nationality.

4. Accommodation Requirement Documents

You need to demonstrate that you have suitable living arrangements:

- **Tenancy Agreement** – If you are renting accommodation.
- **Mortgage Statement** – If you own the property.
- **Landlord's Letter** – Confirming permission for the applicant to reside at the property.
- **Council Tax Bill** – To verify the address.
- **Utility Bills** – Gas, electricity, or water bills showing proof of residence.

5. Tuberculosis (TB) Test Certificate

Applicants from certain countries must provide a valid TB test certificate from a Home Office-approved clinic. The certificate must:

- Include the applicant's name and date of birth.
- Be dated no earlier than six months before the application.
- Include the details and signature of the medical professional.

6. Translation of Documents

Any non-English documents must be accompanied by a certified translation. The translation must include:

- Confirmation that the translation is accurate.

- Date of the translation.
- Translator's full name and signature.
- Translator's contact details.

7. Other Supporting Documents

- **Completed VAF4A Application Form** – Ensure all details are correct and consistent.
- **Valid Passport** – With at least one blank page.
- **Previous Passports** – If applicable.
- **Two Passport-Size Colour Photos** – Recent and compliant with UKVI guidelines.
- **Biometric Information** – Fingerprints and photographs.
- **Proof of Paid Visa Fees** – Receipt of payment for the visa application.
- **Certificate of Criminal Record** – From the applicant's home country (if applicable).
- **Details of Previous Immigration Applications** – If applicable.
- **Parents' Information** – Date of birth and nationality (if applying from outside the UK).

Application Process

1. **Complete the Online Application** – Submit your VAF4A form through the UKVI portal.
2. **Book a Biometric Appointment** – At a visa application centre.
3. **Upload Supporting Documents** – Through the UKVI system or in person.
4. **Pay the Visa Fee** – The spouse visa fee is currently £1,846 for applications from outside the UK.



5. **Attend the Appointment** – Provide fingerprints, photos, and other necessary information.
6. **Await Decision** – Processing times typically range from **8 to 12 weeks**.
